3. By signing this form and paying your adoption fee, you become the legal owner of the dog and MBTCA is no longer legally responsible for the Miniature Bull Terrier.

The undersigned agrees to care for this Miniature Bull Terrier in a responsible manner providing proper food, shelter and medical care as needed, and will restrain this pet appropriately at all times keeping the dog on a leash or in a fenced in yard. The undersigned also agrees that all the pre-adoption forms and home study questions were answered honestly and to the best of their ability.
5. If the adoption fails after a period I the undersigned _____ initial. Agree to contact MBTCA and begin the surrender process. This keeps the Miniature Bull Terrier out of a shelter and in the rescue system. The undersigned also understands that there are no refunds as the adoption fee rarely covers the cost of the animal and having to pay it back would cause MBTCA financial harm.
